The acceptance of the quotations will be subject to the following conditions:-

1. Acceptance of the quotation constitutes a concluded contract. Nevertheless, a successful quotationer must within a fortnight/a month after the acceptance of his quotation furnish 5 percent of the amount of the contract as security deposit and execute an agreement on Kerala Stamp Paper for Rs.200/- at his own cost for the satisfactory fulfillment of the contract, if so required.

2. The items should be delivered at this station, ie, Rice Research Station, Moncompu(Kerala Agricultural University)Thekkekara P.O, Alappuzha-688503, Kerala upon the issuance of supply order. The item supplied will be returned if they do

not meet the stipulated specifications and quality.

3. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchase being made at the offerer's expenses from, elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the University reserves the right to remove the defaulter's name from the list of University suppliers permanently or for a specified number of years.

4. No representation for enhancement of price once accepted will be considered during the

currency of the contract.

5. If any licence or permit is required quotationers must specify in their quotation and also state the authority to whom application is to be made.

6. The maximum period required for delivery of the articles should also be mentioned. Quotations not stipulating period of firmness and with price variation clause and/or 'subject to prior sale' condition are liable to be rejected.

7. Rate quoted should be with 5 % GST for which essentiality certificate will be provided.

- 8. The cost of the item, tax and other charges should be separately stated. Rate quoted should include delivery at site with installation in existing UPS.
- 9. Rate quoted should be against buy back of 20 numbers of old 28 AH 12 V batteries.

10. Prices quoted should be valid up to 31st March 2022 or beyond.

11. The cost of the item, tax, transportation charges, installation charges, demonstration cost and other charges should be separately stated.

12. Warranty period will be 4 years. Details of warranty offered should be clearly stated in
