The maximum period required for delivery of the articles should also be mentioned. Quotations not stipulating period of firmness and with price variation clause and/or 'subject to prior sale' condition are liable to be rejected.

2. The items should be delivered at this station, ie, **Rice Research Station, Moncompu(Kerala Agricultural University)Thekkekara P.O, Alappuzha-688503, Kerala** upon the issuance of supply order. The item supplied will be returned if they do not meet the stipulated specifications and quality.
3. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchase being made at the offerer's expenses from, elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the University reserves the right to remove the defaulter's name from the list of University suppliers permanently or for a specified number of years
4. No representation for enhancement of price once accepted will be considered during the currency of the contract.
5. If any licence or permit is required quotationers must specify in their quotation and also state the authority to whom application is to be made.
6. **The prices quoted should be inclusive of GST, other charges etc.** which are or may become or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract.
7. The cost of the item, tax ,other charges and Optional attachments for different shaking applications rate should be separately stated.
8. The exact specifications, details of make, model, name of manufacturer, warranty details etc. of the items must be clearly specified.
